.DELTONA, Fla. – A Florida jury has found a defendant guilty of two charges for pointing a gun at a man who was trying to get back his truck with \$12,000 worth of drugs inside. The Daytona Beach News-Journal reported that 56-year-old Tiberius Antwaine Ray was found guilty Thursday of two counts of cocaine possession, two counts of perjury, one count of aggravated assault with a firearm and one count of aggravated assault with a firearm and one count of possession of a firearm by a convicted felon. Before the verdict was returned, deputies said Ray pointed a gun at a witness who was trying to catch the truck driver who allegedly loaded it with the drugs.
